ZI BYLAW CHANGE PROPOSALS - 2015 DISTRICT CONFERENCE CONCERNING: QUALIFICATIONS FOR CANDIDATES FOR THE DISTRICT BOARD

Article XIII Districts, Section 6a. Officers Qualifications.

Rationale:

The current 2014 qualifications for Governor allows for a member to be elected to this role, without having any experience at the District level. This appears to be insufficient for the duties of the governor role as stated in Article XIII, Section 7a, with the first task being to "administer the affairs of the district". The current by-law allows for a Governor candidate who has had no exposure to the business and issues of the entire District. Such exposure could be gained by serving on the District board, in any capacity. The proposed by-law amendment addresses this by adding: **The governor shall also have served in an elected or appointed capacity on the District Board.**

Article XIII Districts, Section 13. Nominating Committee Qualifications.

Rationale:

While the ZI By-laws state minimum qualifications for elected officers of the District Board, there is no explicit statement of the qualifications required to serve on the District Nominating Committee, beyond being a member of Zonta International. This means that a Zontian with no Zonta leadership experience or District experience could be elected to serve on the District nominating committee. As stated in the Zonta International District Manual, "The nominating committee plays a vital role in determining who will lead the district in the future." Given the nature of this role, we suggest that those who serve on the District Nominating committee must have similar leadership qualifications as those they are nominating, whose minimum qualifications are described in Article XIII, section 6a. In addition, as the focus of this Committee is district-wide, these members should also have served in some capacity at their District level as a basis for understanding the District and its needs.
